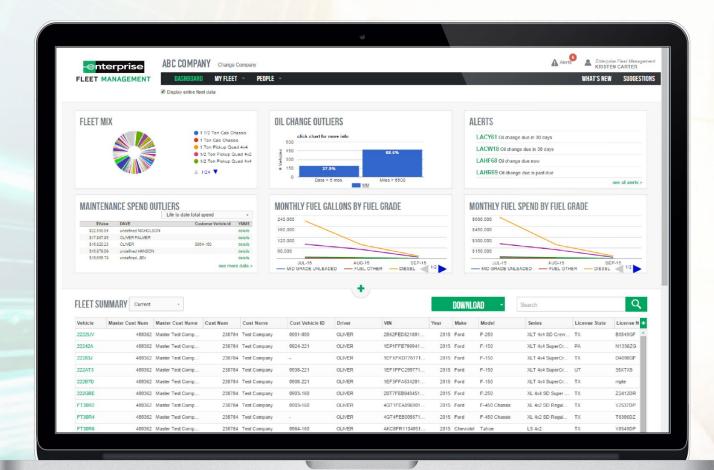
Vehicle MPG Change

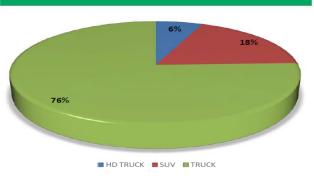

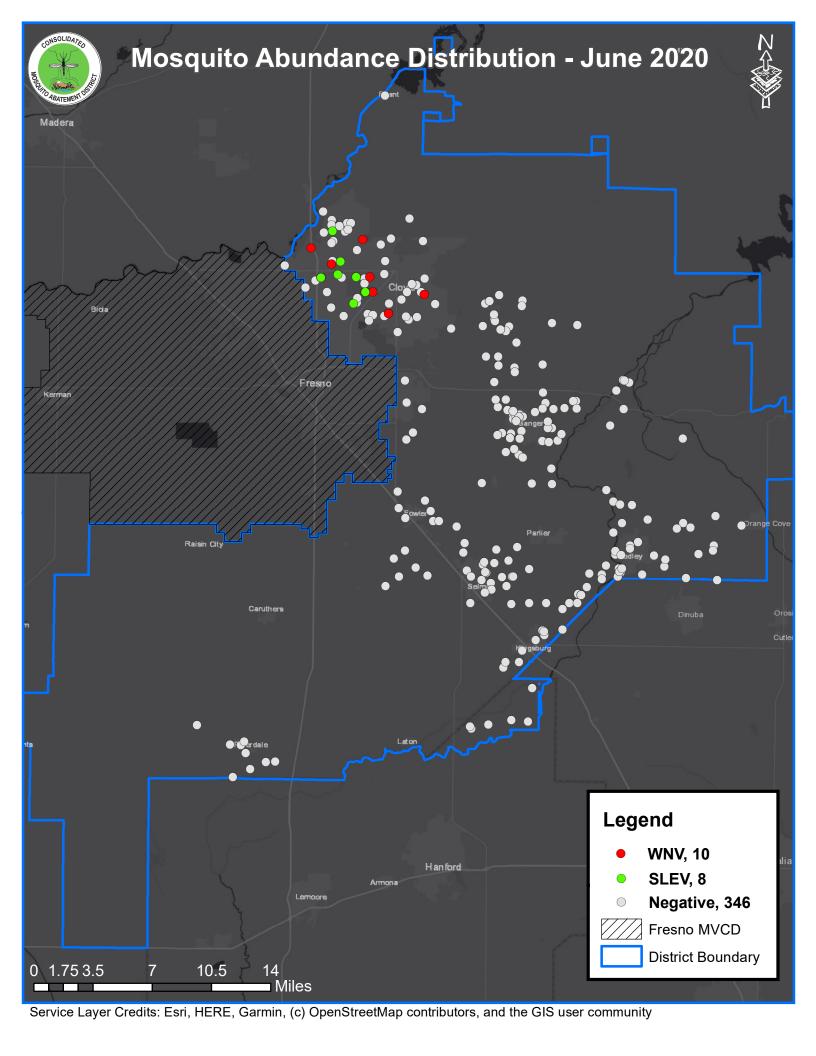


Humans: There are no West Nile Virus (WNV) or Saint Louis Encephalitis (SLE) cases reported within District boundaries.

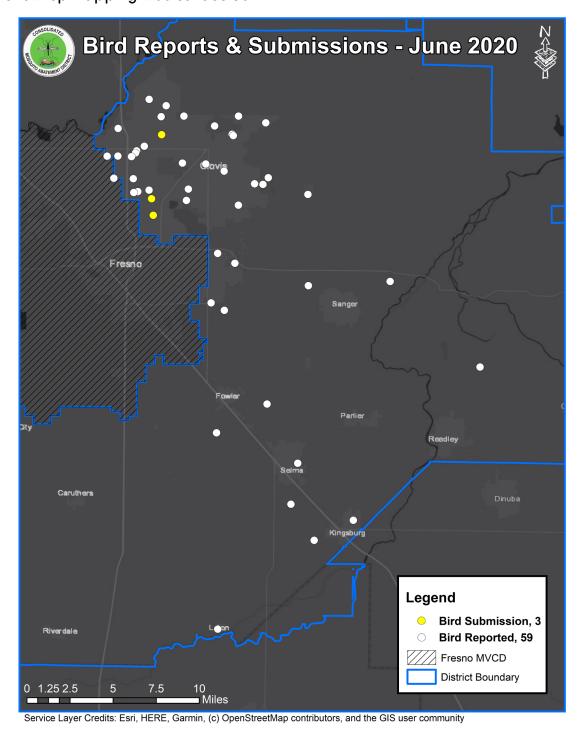

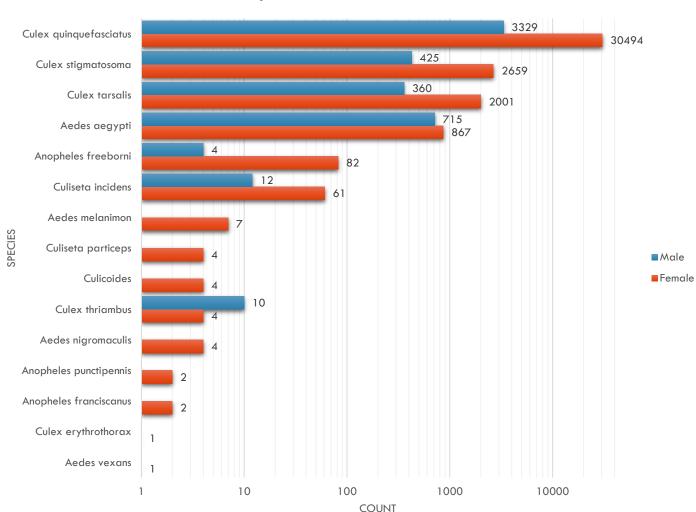


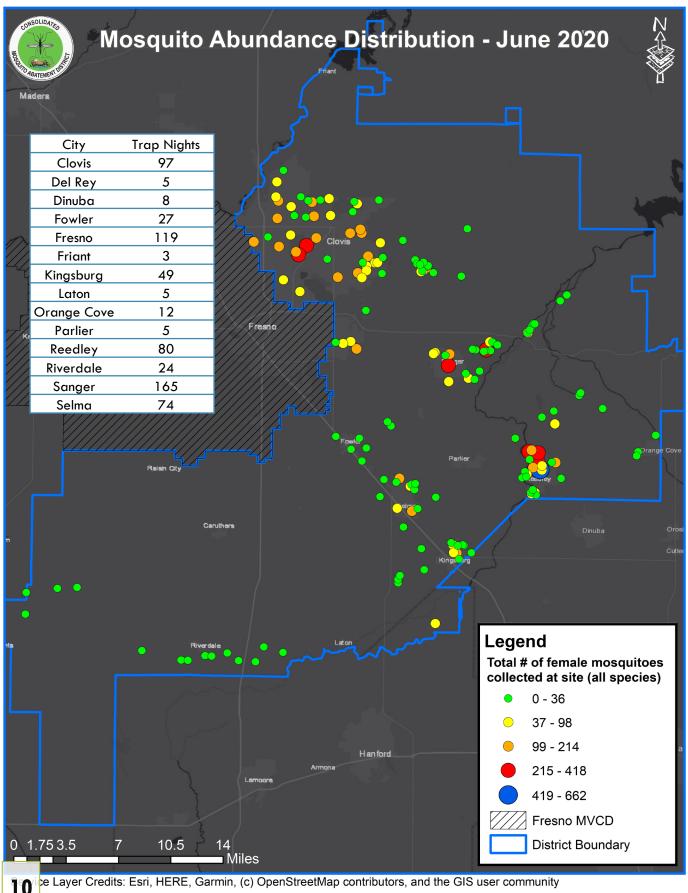

Mosquitoes Collected June 2020



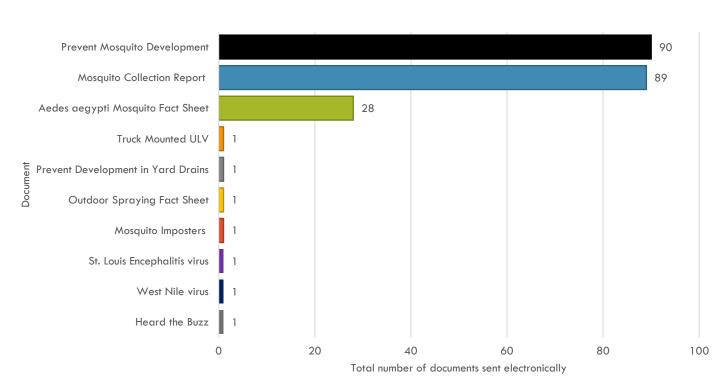

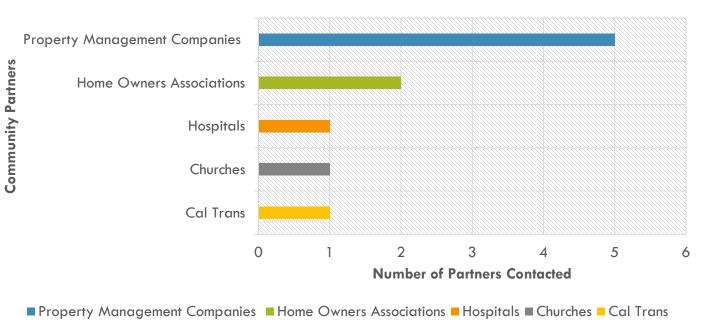




Community Outreach/Presentations

Community Partners Contacted in June

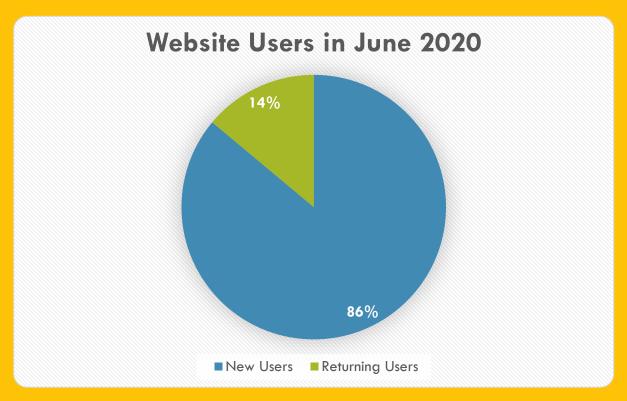

NEWS MEDIA

In June, the District was notified of the first collected the first West Nile virus positive mosquitoes (collected May 29th) and issued a joint press release with Fresno County Department of Public Health on June 4th, 2020. The press release triggered two television interviews, local ABC news channel 30 and local Telemundo news channel 51. Both remote interviews were on June 4th, with ABC interviewing District Manager, Steve Mulligan and Telemundo interviewing Science Education Coordinator, Katherine Ramirez.

Steve's interview was later featured in a TikToc video by a member @realadamrose and liked by 1.4 million people. TikToc is a platform that showcases short-form mobile videos. Their mission is to inspire creativity and bring joy. This feature was not the direct effort by the District and was not aimed at educating residents however it's view count is significant and likely resulted in in greater awareness of mosquito borne-disease activity in Fresno County.



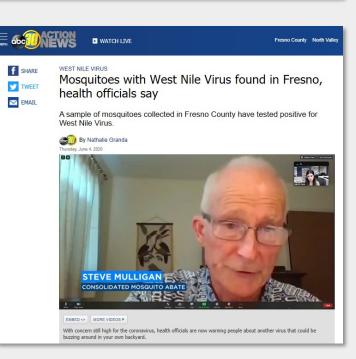
